

This includes any behavior whether physical, verbal or non-verbal of a sexual nature, either by fellow students, faculty or non-teaching staff. The complainant can connect with the Internal Committee through many ways. Email the complaint or request for a meeting with the Committee via the telephone operator or approach any of the members while on campus. The complaints will be looked into in a time bound manner without infringing on the privacy of the complainant. The Committee holds two formal meeting in a year along with additional meetings whenever required.
